116.0 APOLOGIES

6 parishioners

Apologies were received and accepted from Councillor I Redfern, Councillor Tylee, & SDDC Councillors Billings and Plenderleith.

117.0 PUBLIC PARTICIPATION

Councillor Henderson welcomed everyone to the meeting for the discussion on dog waste bins for the village and circulated pictures of dog waste bins.

Mr Partridge felt there was no evidence for or against having dog waste bins and suggested that we have the bins on trial. It would be pointless to have 1 bin: 3 would be more beneficial. Most people are responsible with litter but unfortunately, we could still expect to have problems with dog waste. Councillor Henderson explained that this was not possible to have a bin on trial, as we must purchase the bins and cannot return.

Mr Wallis, village lengthsman, stated that the litter bin on the new playing field is over flowing with dog waste and due to health & safety concerns he would not be emptying it. Also, when footballers use the field they leave their empty drinks bottles by the goal posts. The bin on the footpath by the Holly Bush is also full of dog mess. Councillor Henderson confirmed that the Parish Council do not expect the lengthsman to empty the bins now they are being used for dog waste and SDDC would be requested to empty.

Parishioners stated that some people do not like to pick up their dog's faeces and carry the bags around on their walk. Sometimes people just leave the bags anywhere, or hang in bushes or trees, and hopefully remember to collect on their return.

If there are no dog waste or litter bins people dog faeces would be left on grass verges or bags left anywhere. Mr Wallis explained that dog waste bags just dropped on the ground are often torn open by wildlife and the lengthsman cannot pick up the bags without getting the faeces on their equipment/gloves.

A parishioner stated that dog owners must be responsible for their dogs but if the parish does not provide facilities people will use whatever bins they find.

Councillor Patten suggested the SDDC dog warden could be asked to patrol the village. Local villages of Etwall and Hilton both have dog waste bins and unfortunately when they are full people tend to leave the bags on top of the bin!

Mr Wallis advised that he has reluctantly not cleared the leaves off the path leading to school because when he tried, he discovered dog waste under the leaves and it became entangled in his brush.

Another parishioner was horrified that the village was considering having dog waste bins and thought dog owners should take responsibility for their dogs and the Parish Council should be more pro-active about litter on surrounding lanes.

Dog waste is unpleasant if left; and a health hazard to humans and animals.

Peoples attitudes to litter and dog waste needs to be addressed.

Councillor Henderson explained that SDDC would need to empty the bins each week and the parish would be charged for the purchase, installation and emptying.

It was decided that there are 3-4 main walking routes around the village and it would be beneficial to have a bin on each of these routes e.g. New Playing Field, Tippers Lane and the end of Chapel Lane. Councillor Henderson advised that the Council would make the decision where to place the bins, taking into consideration SDDC requirements for emptying of bins.

Councillor Henderson asked parishioners to vote for or against dog waste bins. Letter votes from parishioners unable to attend would be included. Voting was as follows: For dog waste bins 6 and against 4.

Councillor Henderson confirmed that the Parish Council would organise the purchase and installation of the bins and would review the situation in 9 month's time. Clerk to ask SDDC to empty general waste bins until new dog waste bins installed. ACTION: CLERK

118.0 REPORTS FROM DISTRICT & COUNTY COUNCILLORS & POLICE

Councillor Billings had been advised by Adrian Lowery, Housing & Environmental Services SDDC, that officers have visited the travellers site on Sutton Lane and the 1000 litre bins provided are of sufficient capacity to service the site when fully occupied. Officers were satisfied that the level of provision is in line with their duty under the Environmental Protection Act. Councillor Redfern queried if the travellers when paying for these larger bins as the general public would have to? ACTION: COUNCILOR PATTEN

The lights at Mount Pleasant have been repaired.

Councillor Patten chasing road repair at the junction of Sutton Road and Hilton Straight.

Councillor Patten advised that DCC have been informed that BT will be providing better broadband provision for rural communities. Further information to follow. ACTION: COUNCILLOR PATTEN

New Playing Field – Councillor Henderson advised that he has been in contact with Sarah Collins at SDDC who has advised that all matters relating to the lease renewal are to be managed by SDDC. SDDC are aware that 2 of the 3 owners wish to gift the transfer of their ownership of the land to the Parish Council on the understanding that the land is named after their father Jack Pratt and it is written into the agreement if the Parish Council ever sell the land a percentage of the value is return to them. Unfortunately, the 2 sisters are not in contact with their other sister. Councillor Henderson suggested to Sarah Collins that it would beneficial for SDDC to organise the lease and contract. Councillor Spalton confirmed that the land covers approximately 2/3 of acre. The Parish Council would be liable for the insurance and cutting of the grass if the lease was successful.
