6. A planning application has been received for the Leavesley site on Woodyard Lane which is in Foston and Scropton Parish. Concern has been raised over traffic and any comments to be sent to DDC Councillor Patten.

7. DDC Councillor Patten has contacted Mr Hanbury re traffic on Ashbourne Road, Church Broughton asking if he could look at this matter with any suggestions to be made within policy. No further information has yet been received.
Parishioners raised concern over the flooding on Ashbourne Road when the area received very heavy rainfall in August. Traffic had to drive on the wrong side of the road when travelling around a blind corner. The flooding was reported to highways who placed warning signs in the area. Report number F599621.
Parishioners reported a problem with drains between The White House at the crossroads and Oak Tree Farm. Councillor Billings to investigate. ACTION Running water on Ashbourne Road has eroded the grass verge.
Parishioners raised concerns again with speeding vehicles on Ashbourne Road and SSDC Councillors suggested reporting to Crest Derbyshire instead of the police.

This had been caused by stakes being pushed between the brick work /soil and concrete being inserted, thus causing the wall to bow. ## METHODIST CHAPEL & COMMUNITY PLAN UPDATE

An email had been received from Cliff Lewer on behalf of the Methodist Circuit Leadership Team to Mark Henderson advising the following:

- 1. The minimum lease to allow the premises to be used for serving of alcohol and that raffle s can be held is 10 years.
- 2. A rental of £5200 per annum had been quoted after taking professional advice and this figure may be reduced a by a few hundred pounds. They would not be able to consider a rental of £2000 per annum. Also, insurance and maintenance would be applicable on top of rental. Therefore, the cost per annum could be £130/£150 per week.

Councillors discussed the proposal and felt that it was not affordable. The Methodist Circuit would then be obliged to place the premises on the market to get the best possible price. A Community Asset order has been placed on the Methodist Chapel; therefore, the owners cannot sell for 6 months to allow the parish to buy.
